



## PUBLIC NOTICE OF PROCLAMATION

TAKE NOTICE THAT WE, TE HAPU O HE WHAKAMINENGA WAHI O :MARSICH-CROWN-KINGDOM:®©™® O NU TIRANI/AOTEAROA O TE IKA A MAUI O TE MOANA NUI A KIWA AND; :TE-WHARE-MATAMUATANGA-O-IO-AOTEAROA-KAWANATANGA:®©™® O TE IKA A MAUI O TE MOANA NUI A KIWA, IN OUR NATIVE TRIBAL AUTHORITY OF (TE WAIARIKI) NATIONS PROCLAIM OUR ROHE TERRITORY TO BE; TAI TOKERAU, NU TIRANI/AOTEAROA, ZEALANDIA, TE IKA A MAUI O TE MOANA NUI A KIWA, PAPTUANUKU-NA-AOTEAROA, DOMINION OF GOD, THE KINGDOM OF HEAVEN ON EARTH [AOTEAROA].





AND WE PUBLICALLY PROCLAIM OUR FULL RIGHTS, POWERS AND PRIVILEGES TO REIGN, RULE AND TO GOVERN IN OUR FULL CAPACITY OF LAWFUL ADMINISTRATIVE GOVERNANCE BODY IN ACCORDANCE WITH AND PURSUANT TO OUR UNEXTINGUISHED ALLODIAL NATIVE TITLE TO OUR WHENUA OF TE WAIARIKI ROHE, TAI TOKERAU, NU TIRANI/AOTEAROA, ZEALANDIA, TE IKA A MAUI O TE MOANA NUI A KIWA, PAPATUANUKU-NA-AOTEAROHA, DOMINION OF GOD, THE KINGDOM OF HEAVEN ON EARTH [AOTEAROHA].

That in Full Rights Powers and Privileges of Native Sovereignty; Mana and Tino Rangatiratanga Legally constituted in accordance with “**He Whakaputanga o te Rangatiratanga o Nu Tirani 1835**” We, Ko matou ko nga Tino Rangatira o nga iwi o Nu Tirani i runga mai o Hauraki, ara ko TE HAPU O HE WAKAMINENGA WAHI O :MARSICH-CROWN-KINGDOM:®©™® O NU TIRANI/AOTEAROA O TE IKA A MAUI O TE MOANA NUI A KIWA AND; :TE-WHARE-MATAMUATANGA-O-IO-AOTEAROHA-KAWANATANGA:®©™® O TE IKA A MAUI O TE MOANA NUI A KIWA, IN OUR NATIVE TRIBAL AUTHORITY OF (TE WAIARIKI) NATIONS PROCLAIM OUR ROHE TERRITORY TO BE; TAI TOKERAU, NU TIRANI/AOTEAROA, ZEALANDIA O TE IKA A MAUI O TE MOANA NUI A KIWA, PAPATUANUKU-NA-AOTEAROHA, DOMINION OF GOD, THE KINGDOM OF HEAVEN ON EARTH [AOTEAROHA] as recognized in the protectorate Statutes in Westminster we therefore proclaim that: in our Native Status having pre-existing rights in land property upon the Dominion of the Native Chiefs and Native Tribes, in our collective Capacity we also refer to Whenua Tuku Iho as Dominion of Papatuanuku-na-Aotearoha, and/or “Dominion of God” as our pre-existing property rights many thousands of years before the presumptions made by both Abel Tasman and Captain James Cook’s pretended doctrines of discovery conveyance survey claims to their Paper Maps or Paper Titles masquerading as the Actual, and to say that their fictitious paper titles in the form of pretended conveyances or pretended conveyances leases or whatever their “Straw land” represents, are synonymous to Fictitious Conveyances, in that all paper titles created by the British Citizen’s unconstitutional Native Land Courts since 30<sup>th</sup> October 1865 (their Courts having no de jure standing, and the 1860 Land Registry Act, 1865 Native Lands Act, 1870 Land Transfer Act, which was legislative theft, saw millions of acres transferred to Pakeha (and derivatives of European) ownership, was ultra vires the 1835 Whakaputanga Constitution for the conversion of traditional communal landholdings into Pakeha (and derivatives of European) individual titles, such fraudulent conveyances are null and void ab initio as **the onus of proving extinguishment lies on the Crown and the**

The official proclamation being declared in the Marae Whare-nui o Te Tii o Waitangi on the 27<sup>th</sup> October, 2016, in the company of Nga Tino Rangatira o Nga Hapu o Nga Whare Whakaminenga wahi o Maori Government of Aotearoa, Nu Tirenī and Ko Huiarau, Te Whare Ariki o Runga and Maniapoto Maori Government NZ representatives and a crowd of whanau and hapu representation as witnesses of the proclamation declared.
