PARAMOUNT CHIEF PROCLAMATION AND DECLARATION NOTICE STATEMENT OF CLAIM

27th September, 2018

This NOTICE has been filed in the House of Records for Te Whare Matamuatanga o IO Aotearoha Kawanatanga and the ‘:Marsich-Crown-Kingdom: for the Houses of Moetara (1), Hemara, Mare-Marsich, Rika-Heke, Heta, Marsich, Mullins, Manukau-Marsich, Haywood, Winter, Potter, Crown and Marsich Crown of (6+) Six Plus Generations. I :Gavin-John: :Marsich:®©™® aka; :Ariki-nui-Kawenata: :Crown:®©™® was called into the Marae Whare-nui by Ariki Hohepa Epiha, just after a formal presentation from the Maniapoto Maori Government NZ with Sue Nikora, Georgi Job and Alfred Mitchell. I stood with a presence of God in Te Tii o Waitangi Marae Whare-nui, House of God to declare and proclaim my status as a Tau Iwi Paramount Chief, direct descendant to tohu signatories Paramount Chief Te Heke URUROA Rewharewha and Paramount Chief MOETARA Motu Tongaporutu of He Whakaputanga o te Rangatiratanga o Nu Tirani on the 27th October, 2016.

The proclamation was declared in front of a Maori House of Representatives of the NZ Maori Council Taumata o nga Rangatiratanga o nga Hapu o Te Wakaminenga o wahi o Maori Government NZ of Nu Tiren [New Zealand] Aotearoa, Kohuiarau, Maniapoto Maori Government NZ and an estimated (50) fifty witnesses as a collective were present on that day.

A clear Statement of Claim was verbally spoken into existence to clarify why I was there, whom I represented, who I was and the authority I came with. It was accompanied with my whakapapa and pepeha and a message to return back to our Creator IO Matua Te Runga Rawa, Father Most High Io-nui Io, spoken clearly to the Maori House of Representatives. This was part of my introduction....

“IAM Atua-Ariki, a Tohunga, Matakite, Rangatira, Kingi, Tane Tuatahi and Tama-Ariki of God. No-one HERE can tell me IAM not! You do not have the authority to do so. IAM here to gather the Ariki, Tohunga, Rangatira, Matakite, Tama-Ariki who have been called to be chosen. Please come and speak with me”.

Not one soul at Waitangi challenged or rebutted my Statement of Claim in the Marae Whare-nui (House of God) or outside of it. This indicated social and tacit agreement or silent agreement in collective assembly of congress.
